# I. Benefits:

All New Entrants will be governed by the "New Pension Scheme" based on defined Contributions for new entrants recruited in Central Government Services on or after 01-01- 2004, as adopted by CSIR for its employees. ## II. AGELIMITANDRELAXATIONS:

- 1. The date for determining the upper age limit, qualifications and/or experience shall be the closing date prescribed for receipt of Applicationform **i.e.21-04-2021.**Relaxation of age in respect of Ex-Serviceman will be as per G.O.I Orders.
- 2. The SC/ST/OBC candidates who apply against unreserved (UR) post will not be eligible for age relaxation.
- 3. Upper age limit is relaxableupto 5 years for the regular employees working in CSIR Laboratories/institutes, Government Departments, Autonomous Bodies and Public Sector Undertakings.
- 4. Relaxation in the upper age limit of 5 years applicable for persons who had ordinarily been domiciled in the Jammu and Kashmir State during the period 1-1-1980 to 31-12-1989 subject to production of a certificate from the District Magistrate in the Kashmir Division within whose jurisdiction he/she had ordinarily resided or from any other authority designated in this behalf by the Government of J&K to the effect that he/she had ordinarily been domiciled in the Jammu and Kashmir union territory (ErstwhileState)during the period from 1-1-1980 to31-12-1989.

## III. **GENERALCONDITIONS**:

- 1. This position is open only to IndianNationals.
- 2. The appointment will be in the CSIR-National Metallurgical Laboratory (NML), Jamshedpur, under the Council of Scientific & Industrial Research (CSIR) which is an Autonomous Body. However, the appointee is liable to be transferred toany of the Labs/Institutes of CSIR situated anywhere in India as and when required at the discretion of CompetentAuthority.

- 4. Eligible candidates may down load the application forms and should fill the form in all respects.
- 5. The filled in APPLICATIONFORM duly signed, along with self-attested copies of certificates i.e. experience certificates, documentary proof in support of date of birth, and applicable fee of Rs. 100.00 in the form of Demand Draft favouringTHE DIRECTOR, <u>National Metallurgical Laboratory (NML), Jamshedpur</u>, payable at State Bank of India, NML Branch, Branch Code- 03329, Jamshedpur should be sent to The Controller of Administration, CSIR-National Metallurgical Laboratory, Burmamines, Jamshedpur 831007 Jharkhand, so as to reach on or before 21-04-2021.
- Application fee is Non-refundable and the Demand Draft (DD) should be valid for a period of at least 3 months. The following details must be written on the backside of D.D. — (a) Candidate's name; (b) Post applied;
- 7. The Advertisement Number and Post Code must be clearly indicated on the top of the envelope containing the application. Women candidates and departmental candidates (from CSIR Laboratories /Institutes) need not pay any application fee.
- 8. If any document/certificate furnished is in a language other than Hindi or English, a transcript of the same in English duly attested by a Gazetted Officer or Notary is to besubmitted.
- 9. Application form of the candidates working in CSIR, Govt. Departments and Public Sector Undertakings will be considered<u>onlyif the candidates enclose the competent authorities</u> <u>approval alongwith other documents while submitting applications</u> and with a clear certificate that the applicant will be relieved within one month of receipt of appointment order, ifselected.

10. Application Form not accompanied with the requireddocuments (i) prescribed application fee wherever applicable; (ii) Proof regarding date of birth &age; (iii) Proof of possession of a valid Ex-servicemen certificate (iv) Experience of Ex-servicemen for at least 10 years and Experience w.r.t. Short Service Commissioned etc., (vii) Signature of candidate and (viii)

applications submitted without certificate with reference to Ex-servicemen and Short Service Commission, will not be considered. Incomplete applications will be outrightly rejected.

- 11.Mode of Selection:
- i) By holding a Physical and Personality Assessment test which will be qualifying in nature.
- ii) Those who qualify in the Physical and Personality Assessment test will be invited for a Written test.
- iii) The final merit list will be prepared on the basis of the performance of the candidates in the competitive written examination.
- iv) The Syllabus of the written test, Physical Standards, Physical Tests andother details of the physical and personality assessment testis attached at **annexure A (Available at NML Website www.nmlindia.org).**
- 12.Only outstation candidates (within India) called for <u>Written test only</u> will be reimbursed Travelling Allowance (TA) as admissible under rules i.e. a single Second Class Railway Fare (by Mail or Express) each way from their normal place of residence or from the place of undertaking the journey, whichever is nearer to Jamshedpur on production of proof of journey. For road journeys between stations not connected by rail, the actual bus fare or road mileage at the lowest rate as admissible under rules, will be reimbursed, on production of documentary proof (bus tickets) provided that the distance covered by road is more than 20 KM each way.
- 13.CSIR-NML reserves the right not to fill up the post, if it so desires.
- 14. The selected candidate will be on probation for a period of one year from the date of taking over charge of the post. The probationary period may be extended or curtailed at the discretion of the Competent Authority. After successful completion of probationary period, he/she will be considered for confirmation in accordance with the extant rules.
- 15. The selected appointee should be ready to work beyond office hours whenever need arises to meet Laboratory schedules.
- 16. The selected candidate will not be permitted to apply for appointment elsewhere or in CSIR-NML during the probationary period and if they have already applied for any posts in any other organization they may have to intimate the details of such applications, immediately after joining the Laboratory.
- 17.It is necessary that only accurate, full and factually correct information should be furnished by the applicants. Furnishing of wrong / false information will be a disqualification and CSIR-NML will <u>NOT</u> be responsible for any of the consequences of furnishing such wrong / false information.

The decision of CSIR-NML in all matters relating to eligibility, acceptance or rejection of applications, mode of selection, conduct of Physical and personality assessment test and Written Test will be final and binding on all the candidates and no enquiry or correspondence will be entertained in this connection from any individual or agency on behalf of the candidate.
