Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. Scope of supply (Bid price to include all cost components) : Supply Installation Testing Commissioning of Goods and Training of operators and providing Statutory Clearances required (if any)

2. Buyer Added Bid Specific ATC

Terms & Conditions

- 1. Scope of Supply:** Supply, installation, Testing and Commissioning of Goods.
- 2. Qualification Requirement:** Please refer to the technical specifications of the bid document.
- 3. Delivery Period:** Delivery should be completed in full within a period of ninety (90) days from the date of purchase order. Liquidated Damage clause will be imposed in the event of non-completion of delivery within the stipulated time.

4. **Liquidated Damage clause:** The penalty shall be 0.5% per week or part of a week towards late delivery and installation, commissioning, training etc. including all contractual obligations beyond contractual deadline. The maximum amount of penalty shall be 10%.
5. **Delivery Site:** Delivery F.O.R. CSIR-NML, Jamshedpur-831007 (Jharkhand).
6. There can be only one bid from the following:
 - a. The original manufacturer directly or through one authorized dealer on his behalf; and
 - b. Authorized dealer on behalf of only one manufacturer.
7. **Installation and commissioning:** To be installed at site by the supplier within thirty (30) days from the delivery period. The supplier shall also have to impart necessary training to three (03) personnel for two (02) days for effective operation and maintenance of the goods. The inspection of the material shall be done within 30 days after installation of the goods.
8. **Warranty:** 01 (one) year from the date of successful installation and commissioning.
9. **AMC:** Vendor must quote consecutive 1 year non-comprehensive AMC rate (minimum 02 preventive + 1 breakdown) for equipment after warranty. The prices will be included in evaluation.
10. **OEM Certificate (applicable for manufacturer only):** In case the Bidder is the OEM, a declaration to this effect must be attached along with the offer. This certificate with valid date must contain Name, Designation, Email Address and Mobile Phone Number of the authorized signatory along with the address of the office.
11. **MAF Certificate (applicable for dealer only) :** In case the Bidder is offering products on behalf of the OEM, a proper Manufacturer's Authorization Certificate (MAF) with valid date must be attached with the quotation and it should contain Name, Designation, Email Address and Mobile Phone Number of the authorized signatory along with the address of the office.
12. **Taxes, Duties etc.:** The buyer should indicate full GST rates.
13. **Make In India:** Preference will be given to offer/s for Class-I MII product. The Bidder must furnish a declaration/Certificate to this effect along with the bid mentioning about the percentage of Local Input of the offered product and the detailed address of the place (manufacturing unit) where the input is being added. The Declaration/Certificate should have full name and designation of the signatory along with his/her email ID, direct phone number, office address.

As per Govt. of India procurement policies the eligibility of the suppliers for this bidding is restricted to Class I and Class II local suppliers as per Department for Promotion of Industry and Internal Trade, Govt. of India, vide OM No. P-45021/2/2017-PP (BE-II) dated 04 June 2020 and OM No. P-45021/2/2017-PP (BE-II) dated 16 September 2020.

14. **MSE:** Preference will be given to MSEs. The bidder must submit valid documents for claiming them as eligible MSEs for the particular bid/item.

16. **Certificate reg. Land Border Sharing is compulsory.** Any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority. While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-

19. **Performance Security:** The vendor has to submit a Performance Security equivalent to 3 (three) per cent of the purchase order value before release of payment. The performance security should remain valid for a period of warranty plus sixty (60) days from the date of successful installation and commission of the supplied equipment.
20. **Bid Securing declaration:** Submission of Bid Securing Declaration is compulsory.
21. **The place of jurisdiction is Jamshedpur, Jharkhand, India.**
22. **Catalogue/Leaflet/Brochure:** Bidder must submit Catalogue / Leaflet / Brochure to justify the specification/feature of their offered equipment.
23. The bidder should **ONLY** attach the requisite documents, asked for. The Bidder should not attach "**IRRELEVANT DOCUMENTS**" or "**DOCUMENTS WHICH HAVE NOT BEEN ASKED FOR**".
24. In the event of non-compliance of any of the aforesaid guidelines, the offer of the bidder may be treated as non-responsive.

Additional Clause For Annual Maintenance Charges

1. AMC charges to be indicated as percentage of cost of Product/Equipment quoted for each year after the warranty period.

2. GST shall be included in the AMC Charges quoted.

3. The AMC functionality shall be available in bid only and no direct RA shall be applicable. In case of bid to RA decrement rules shall be applicable on total price inclusive of AMC charges.

3.1 Buyer shall indicate number of years of warranty by selecting option of 1- 10 Years available in the field depending on warranty parameter applicable in category parameters for the equipment. The Seller while participating in Bid/RA will get fields to indicate AMC charges as percentage depending on number of years of AMC selected by Buyer. The following shall be applicable If 5 year AMC selected.

3.1.1 AMC charges for first year after warranty period – Percentage to be indicated- A1.

3.1.2 AMC charges for second year after warranty period – Percentage to be indicated A2.

3.1.3 AMC charges for third year after warranty period – Percentage to be indicated A3.

3.1.4 AMC charges for fourth year after warranty period – Percentage to be indicated A4.

3.1.5 AMC charges for 5th year after warranty period – Percentage to be indicated A5.

3.2 The calculation of AMC Charges shall take in to account of number of years of warranty and duration of AMC as specified while creating bid.

3.3 AMC charges to be indicated for each subsequent year should be same or higher than preceding year.

3.4 The AMC charges shall be offered within range of 3 to 10% of cost of equipment.

4. Since AMC charges are to be paid only later for each year during AMC period , applicable performance guarantee amount after placement of contract shall be based on the cost of product/equipment and not on basis of cost of equipment along with AMC Charges.

5. Performance bank guarantee applicable for AMC is to be submitted at start of the AMC and shall be applicable as 3% on the total contract value including AMC Charges The PBG submitted after award of contract shall be released only after new PBG for the AMC period is submitted and accepted by buyer/consignee after due verification. Bank guarantee for AMC is to remain valid till completion of AMC period plus one year .The bank guarantee for AMC shall be submitted to buyer directly.

6. In case of splitting of quantity product/equipment cost and AMC charges offered by L-1 in the evaluated cost shall be matched by higher quoting eligible bidders on one to one basis .The equipment cost shall be matched and AMC charges shall be matched year to year.

7. The AMC Contract shall be an offline contract to be handled by buyer. The payment of AMC will be made on AMC frequency (as indicated above) basis after satisfactory completion of said period, duly certified by end user and scope of AMC will be as per para 1 above.
