- 1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% (Selected by Buyer)of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 25%(selected by Buyer) percentage of total QUANTITY. ## 1. Scope of Supply

- 1. **Scope of Supply**: Supply, installation, Testing and Commissioning of Goods.
- 2. **Qualification Requirement:** Please refer to the technical specifications of the bi d document.
- 3. **Delivery Period:** Delivery should be completed in full within a period of sixty (60) days from the date of purchase order. Liquidated Damage clause will be imposed in the event of non-completion of delivery within the stipulated time.
- 4. **Liquidated Damage clause**: The penalty shall be 0.5% per week or part of a we ek towards late delivery and installation, commissioning, training etc. including all contractual obligations beyond contractual deadline. The maximum amount of pen

- alty shall be 10%.
- 5. **Delivery Site**: Delivery F.O.R. CSIR-NML, Jamshedpur-831007 (Jharkhand).
- 6. There can be only one bid from the following:
- a. The original manufacturer directly or through one authorized dealer on his behalf; and
- b. Authorized dealer on behalf of only one manufacturer.
- 7. **Installation and commissioning:** To be installed at site by the supplier within fif teen (15) days from the delivery period. The supplier shall also have to impart nec essary training for 7 (seven) days for 2 (two) personnel for effective operation and maintenance of the goods. The inspection of the material shall be done within 20 d ays after installation of the goods.
  - Acceptance Test: Trial Run.
- 8. **Warranty:** 3 (three) years from the date of successful installation and commission ing.
- 9. **OEM Certificate** (applicable for manufacturer only): In case the Bidder is the OEM, a declaration to this effect must be attached along with the offer. This certificate with valid date must contain Name, Designation, Email Address and Mo bile Phone Number of the authorized signatory along with the address of the office.
- 10. **MAF Certificate** (applicable for dealer only): In case the Bidder is offerin g products on behalf of the OEM, a proper Manufacturer's Authorization Certificate (MAF) with valid date must be attached with the quotation and it should contain N ame, Designation, Email Address and Mobile Phone Number of the authorized sign atory along with the address of the office.
- 11. **Taxes, Duties etc.**: The buyer should indicate full GST rates.
- 12. **Make In India:** Preference will be given to offer/s for Class-I MII product. The Bi dder must furnish a declaration/Certificate to this effect along with the bid mentio ning about the percentage of Local Input of the offered product and the detailed address of the place (manufacturing unit) where the input is being added. The D eclaration/Certificate should have full name and designation of the signatory alon g with his/her email ID, direct phone number, office address.

As per Govt. of India procurement policies the eligibility of the suppliers for this bi dding is restricted to Class I and Class II local suppliers as per Department for Promotion of Industry and Internal Trade, Govt. of India, vide OM No. P-45021/2/2017 -PP (BE-II) dated 04 June 2020 and OM No. P-45021/2/2017-PP (BE-II) dated 16 Se ptember 2020.

- 13. **MSE:** Preference will be given to MSEs. The bidder must submit valid documents for claiming them as eligible MSEs for the particular bid/item.

- 15. **Certificate reg. Land Border Sharing is compulsory**. Any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority. While participating in bid, Bidder has to undertake compliance of this and any false declaration and noncompliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws.

- 18. **Performance Security:** The vendor has to submit a Performance Security equi valent to 3 (three) per cent of the purchase order value before release of paymen t. The performance security should remain valid for a period of warranty plus six ty (60) days from the date of successful installation and commission of the suppli ed equipment.
- 19. **Bid Securing declaration**: Submission of Bid Securing Declaration is compulso ry.
- 20. The place of jurisdiction is Jamshedpur, Jharkhand, India.
- 21. **Catalogue/Leaflet/Brochure:** Bidder must submit Catalogue / Leaflet / Brochur e to justify the specification/feature of their offered equipment.
