1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.

2. If the bidder is a Startup, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to their meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of guality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer. 3. Preference to Make In India products (For bids < 200 Crore): Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. Only Class-I and Class-II Local suppliers as per MII order dated 4.6.2020 will be eligible to bid. Non - Local suppliers as per MII order dated 04.06.2020 are not eligible to participate. However, eligible micro and small enterprises will be allowed to participate .The buyers are advised to refer the OM No.F.1/4/2021-PPD dated 18.05.2023.

4. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have guoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

5. Reverse Auction would be conducted amongst first 50% of the technically qualified bidders arranged in the order of prices from lowest to highest. Number of sellers eligible for participating in RA would be rounded off to next higher integer value if number of technically qualified bidders is odd (e.g. if 7 bids are technically qualified, then RA will be conducted amongst L-1 to L-4). In case number of technically qualified bidders are 2 or 3, RA will be between all without any elimination. If Buyer has chosen to split the bid amongst N sellers, then minimum N sellers would be taken to RA round. In case Primary products of only one OEM are left in contention for participation in RA based on lowest 50% bidders qualifying for RA, the number of sellers qualifying for RA would be increased to get at least products of one more OEM (directly participated or through its reseller) if available. Further, if bid(s) of any seller(s) eligible for MSE preference is / are coming within price band of 15% of Non MSE L-1 or if bid of any seller(s) eligible for Make in India preference is / are coming within price band of 20% of non MII L-1, then such MSE / Make in India seller shall also be allowed to participate in the RA process.

# **Terms & Conditions**

- 1. **Scope of Supply**: Supply, installation, Testing and Commissioning of Goods.
- 2. **Qualification Requirement:** Please refer to the technical specifications of the bi d document.
- 3. **Delivery Period:** Delivery should be completed in full within a period of ninety ei ght days/ Fourteen Weeks (98 days/ 14 Weeks) from the date of purchase order. Li quidated Damage clause will be imposed in the event of non-completion of deliver y within the stipulated time.
- 4. **Liquidated Damage clause**: The penalty shall be 0.5% per week or part of a we ek towards late delivery and installation, commissioning, training etc. including all contractual obligations beyond contractual deadline. The maximum amount of pen alty shall be 10%.
- 5. Delivery Site: Delivery F.O.R. CSIR-NML, Jamshedpur-831007 (Jharkhand).
- 6. There can be only Two bid from the following:
- a. The original manufacturer directly or through one authorized dealer on his behalf; and
- b. Authorized dealer on behalf of only one manufacturer.
- 7. **Installation and commissioning:** To be installed at site by the supplier within T hirty (30) days from the delivery period.—The supplier shall also have to impart ne cessary training for One day for Ten (10) personnel for effective operation and mai ntenance of the goods.
- 8. **Warranty:** 3 (Three) year from the date of successful installation and commission ing.
- 9. **OEM Certificate (***applicable for manufacturer only***):** In case the Bidder is the OEM, a declaration to this effect must be attached along with the offer. This certificate with valid date must contain Name, Designation, Email Address and Mo bile Phone Number of the authorized signatory along with the address of the office.
- 10. **MAF Certificate (***applicable for dealer only***)** : In case the Bidder is offeri ng products on behalf of the OEM, a proper Manufacturer's Authorization Certificat e (MAF) with valid date must be attached with the quotation and it should contain Name, Designation, Email Address and Mobile Phone Number of the authorized sig natory along with the address of the office.
- 11. Taxes, Duties etc.: The buyer should indicate full GST rates.
- 12. **Make In India:** Preference will be given to offer/s for Class-I MII product. The Bi dder must furnish a declaration/Certificate to this effect along with the bid mentio ning about the percentage of Local Input of the offered product and the detailed address of the place (manufacturing unit) where the input is being added. The D eclaration/Certificate should have full name and designation of the signatory alon g with his/her email ID, direct phone number, office address.

As per Govt. of India procurement policies the eligibility of the suppliers for this bi dding is restricted to Class I and Class II local suppliers as per Department for Pro motion of Industry and Internal Trade, Govt. of India, vide OM No. P-45021/2/2017 -PP (BE-II) dated 04 June 2020 and OM No. P-45021/2/2017-PP (BE-II) dated 16 Se ptember 2020.

- 13. **MSE:** Preference will be given to MSEs. The bidder must submit valid documents for claiming them as eligible MSEs for the particular bid/item.
- 14. Other certificate/s :
- 15. **Certificate reg. Land Border Sharing is compulsory**. Any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority. While participating in b id, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract a nd further legal action in accordance with the laws.
- 16. **EMD:** The bidder has to submit an EMD along with the bid for amount mentione d in EMD details. EMD should be provided on the name of Director, CSIR-NML, Jam shedpur.
- 17. **Payment Terms**: Hundred percent (100%) of the Contract Price of Goods received shall be paid within thirty (30) days of receipt of Goods and successful installation & commissioning upon submission of claim supported by the acceptance cert ificate issued by the Purchaser along with the Performance security.

- 18. Performance Security: The vendor has to submit a Performance Security equi valent to 3 (three) per cent of the purchase order value before release of paymen t. The performance security should remain valid for a period of warranty plus six ty (60) days from the date of successful installation and commission of the suppli ed equipment.
- 19. **Bid Securing declaration**: Submission of Bid Securing Declaration is compulso ry.

## 20. The place of jurisdiction is Jamshedpur, Jharkhand, India.

- 21. **Catalogue/Leaflet/Brochure:** Bidder must submit Catalogue / Leaflet / Brochur e to justify the specification/feature of their offered equipment.
- 22. The bidder should ONLY attach the requisite documents, asked for. The Bidder s hould not attach "**IRRELEVANT DOCUMENTS**" or "**DOCUMENTS WHICH HAVE NOT BEEN ASKED FOR**".
- 23. In the event of non-compliance of any of the aforesaid guidelines, the offer of the bidder may be treated as non-responsive.
