- 1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. - 2. **Qualification Requirement:** Please refer to the technical specifications of the bi d document.
- 3. **Delivery Period:** Delivery should be completed in full within a period of Thirty (3 0) days from the date of purchase order. Liquidated Damage clause will be impose d in the event of non-completion of delivery within the stipulated time.
- 4. **Liquidated Damage clause**: The penalty shall be 0.5% per week or part of a we ek towards late delivery and installation, commissioning, training etc. including all contractual obligations beyond contractual deadline. The maximum amount of pen alty shall be 10%.

- 6. There can be only one bid from the following:
