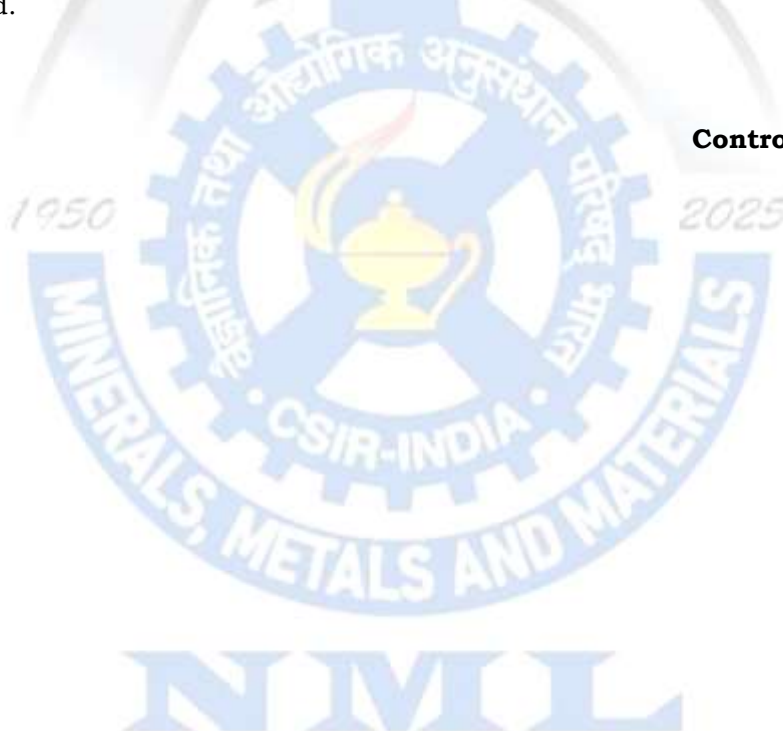
7. The engagement of part-time doctor is subject to the terms and conditions issued by CSIR in this regard from time to time.
