Attention of all concerned is invited to the Institute Advertisement No. 02/2021 regarding recruitment of **Security Officer** under CSIR-National Metallurgical Laboratory (CSIR-NML). Further to that, the following are brought to the Notice for information of all concerned.

As per the said Notice, the candidature of only those applicants whose hard copies of applications were received within the prescribed last date i.e. within 21-04-2021 were to be considered by the Institute and others to be rejected. Accordingly, the Screening Committee scrutinized the applications which were received within the stipulated date and time with respect to the eligibility criteria as stipulated in the Advertisement No.02/2021of CSIR-NML.

The following Codes have been used during the screening process for recommending the candidates to be provisionally eligible/ineligible for Physical Standards & Physical test. The basis for such recommendation has been given in form of relevant codes as enumerated below:

- SC-1 : Essential qualification and experience as per advertisement No.02/2021.
- SC-2: (a) The date for determining the upper age limit, qualifications and/or experience shall be the closing date prescribed for receipt of Application form i.e. 21-04-2021. Relaxation of age in respect of Ex-Serviceman will be as per G.O.I Orders.
  - (b) The SC/ST/OBC candidates who apply against unreserved (UR) post will not be eligible for age relaxation.
  - (c) Upper age limit is relaxable upto 5 years for the regular employees working in CSIR Laboratories/institutes, Government Departments, Autonomous Bodies and Public Sector Undertaking
- SC-3 : Not fulfilling the general conditions as per advertisement No.02/2021.

Accordingly , the list of those candidates who are considered provisionally eligible / ineligible on the basis of essential criteria like age, experience etc whose hard copies of applications have been received within the stipulated date is enclosed as **Annexure-I** with specific mention of the same in the Annexure-I.

It is notified that the applicants found provisionally eligible at this stage would be required to appear for the Physical Standards & Physical test, the date(s) for the same will be notified shortly. The candidates who qualify in the Physical test would be called for the Written test subsequently. The Physical Standards & Physical test date may continue to the next date too, hence the candidates called for the same may come prepared to stay at the notified city for the next day too at their own expenses and arrangements, if circumstances

so requires. They will be required to comply all COVID19 related stipulations of the Government of India & Govt. of Jharkhand issued from time to time.

It may be noted that the Screening process of the applicants has been carried out on the basis of information furnished in the Application form and the documents furnished by the candidates. If at any stage during the screening/selection process or even after their joining to the post, it is detected that the candidate is not eligible for the post for not possessing the required eligibility criteria etc or has furnished false information his/her candidature may be summarily rejected/terminated without assigning any reason and appropriate action may be taken in this regard.
