CSIR- NATIONAL METALLURGICAL LABORATORY, Jamshedpur is a pioneer research and development institute under the aegis of Council of Scientific & Industrial Research, an autonomous body of DSIR, Ministry of Science & Technology, Govt. of India. We are interested in appointing an authorized & reputed Custom House Agent(CHA) cum Consolidation Agent cum forwarding agent to perform the jobs related to the consolidation and clearance of Import/Export consignments (without demurrage) etc. Most of our imported consignments comes on EXW, FCA, CPT, CIP, DAT, DAP, DDP (by air) and on FAS, FOB, CFR, CIF (by sea) or latest Incoterms . Concessional rate of custom duty is applicable to CSIR-NML as we are covered under the notification 51/96-customs dated 23/07/2016 and amended time to time. We hereby invite two bid tenders (Technical bid + Commercial Bid) from reputed Custom House Agent(CHA) cum Consolidation Agent for a period of <u>ONE YEAR subject to renewal on annual performance basis</u> as per the scope, terms and conditions and other details mentioned herein under: -

Interested Bidders are requested to submit the online quotation in favor of Director, CSIR-NML. The quotations will be opened as per GeM Portal due date in Purchase Section of CSIR-NML.

Bidders may download the Tender Document from CSIR-NML website i.e. <u>www.nmlindia.org</u> or through https://gem.gov.in.

Terms and Conditions on which the Contract has to be awarded are given below: -

Terms and Conditions 1) Scope and tenure of the contract:

Includes all the work related to the consolidation and clearance of all the Import/Export of various types of consignments of CSIR-NML coming by air/sea/courier/post modes of transport from throughout the world. The CHA should be capable of freight forwarding & consolidation of consignments. Insurance of all the consignments is to be arranged by the CHA and delivery of the consignments up to CSIR-NML, Jamshedpur. Our most of the consignments comes via the Kolkata Airport.

This contract shall be valid for a period of one (01) year from the date of award of contract subject to renewal on annual performance basis.

The job shall broadly involve:

A) Customs clearance of imported consignments from IAAI/ICD/Foreign Post Office against filing of bill of entry.

- i) The clearance of precious and delicate type of Equipments, Instruments, Consumables and other special type of materials, etc.
- Custom clearance of the consignment including all the stages of customs clearance
- Obtaining Non-delivery certificate/short landing certificate in the case of materials are short delivered by IAAI, or airlines and lodging of claims with them immediately on behalf of CSIR-NML.
- Arranging insurance survey at airport/IAAI in case of damages to the consignment.
- Immediate delivery of consignment at CSIR-NML, Jamshedpur after custom clearance.
- ii) Any other job in connection with the clearance of goods from Customs.

- iii) Clearance of IPP Parcels from customs/Foreign Post Office, Delhi/ Chennai.
- iv) Clearance of consignments from Customs at Kolkata.
- v) Clearance of consignment under temporary imports/ATA carnet/warranty repair/replacement etc. For further exporting to another country.
- vi) Clearance of consignments from courier mode like UPS/Blue Dart/Fed-Ex or any other courier agency etc.
- vii) The successful bidder (CHA) will have to arrange insurance for all the import/export consignments of CSIR-NML (payable on actual basis). It excludes the consignments wherein the supplier has already agreed to pay insurance charges as per the related INCOTERM mentioned in our order. In India insurance for non-console cases will have to be done by the CHA (payable on actual basis) (Please attach undertaking to this effect)

B) Consolidation of the consignments being imported from throughout the world:

- i. Complete monitoring and supervision of the movement from the date of order/LC and regular feedback on the progress of order to CSIR-NML.
- ii. In case feedback as detailed above is not received before landing of the consignment the delay in clearance will be on the part of Agent and the respective amount of demurrage will be recovered from the bill. CSIR-NML will not pay any amount on account of demurrage charges.
- iii. To provide timely information (pre-alert) regarding dispatches and other relevant information to CSIR-NML.
- iv. To facilitate specialized packing from all kinds of materials as per the IATA specifications and international packing standards.
- v. Smooth transportation of special projects materials voluminous and heavy packages, sensitive and hazardous materials.
- vi. Extensive communication through telephone, tele fax and Email etc.
- vii. Providing IATA rates/ex-works rates of wherever needed during contract.
- viii. Shipments may be made preferably through Indian national carrier (Air India) and routed through the friendly countries of India. (Please attach undertaking to this effect)
- ix. Re-Export/ Re-Import of defective/damaged items to the various countries of import for repair or replacement purpose (including items for calibration and other scientific work) by air or sea. CHA will have to complete all the related formalities related to this.
- x. Any other job in connection with the consolidation &clearance of the consignments from customs authorities.

C) **Exports to various countries:**

- i) Export of defective/damaged items to the countries of Import.
- ii) Export of consignment Imported temporally.
- iii) Export of items for repair, calibrations and other scientific work.

Terms and conditions:

- 1. **Period of Contract:** The contract period is for 1 (One) year subject to renewal on annual performance basis. It means the contract will be initially awarded for 1 year and may be further renewed on annual basis subject to & based upon the satisfactory services/performance of the CHA.
- 2. **Earnest Money Deposit:** -An earnest money deposit (EMD) of Rupees 50,000.00 (Rupees fifty thousand only) has to be deposited by the bidder along with their technical bid only in the shape of NEFT/RTGS/FDR/ Bank Guarantee(as per annexure 'C') / Bid Securing Declaration (as per annexure E) in favour of 'The Director, CSIR-NML, Jamshedpur'. The technical bid not accompanied with the requisite EMD will be straight way rejected and no correspondence will be entertained in this regard. EMD of successful tenderer is returnable only on submission of performance bank guarantee (PBG). However, exemption will be entertained as per extant GOI instruction for MSEs and Start-ups bidder.
- 3. **Performance Bank Guarantee(PBG) :** The successful bidder will have to deposit within 21 days of receipt of award of contract, an unconditional performance bank guarantee of Rs. 2,00,000.00 (Rupees two lakh only) valid till the

contract period + 60 days (as per annexure 'D'). The same PBG will be refunded/returned after completion of contract. However, The Director, CSIR-NML will have the discretion to order for the forfeiture of deposit for any breach of contract. The bank guarantee may be further extended in case the contract is extended.

- 4. <u>Location of the Bidder:</u> Our most of the consignments arrives via Kolkata Airport, India. Therefore, the bidder must have uninterrupted consignment clearance arrangements at Kolkata Airport. The bidder should be registered as CHA and consolidator (both) in its own name at the Kolkata airport authorities for at least 3 years or more (Supporting document must be attached to this effect). The bidder should also have facilities to undertake clearance and delivery of sea consignment and post parcels (without any demurrage) as and when required by CSIR-NML.
- Submission of Bills: Pre-receipted bills (in triplicated copy) shall be submitted within one week from clearance of consignment for service provided to CSIR-NML, Jamshedpur as per rates attached at Annexure. Bills should be in compliance of relevant GST rules and must show all the charges separately. A checklist and documents in support of various charges indicated in the bill should accompany each bill and must be counter signed and stamped by service provider. Any bill not accompanied by checklist and one or more documents, will not be accepted in CSIR-NML Jamshedpur. Person authorized by CSIR-NML, Jamshedpur will acknowledge receipt of the bills after due verification of enclosure(s). Bills those are returned on account of deficiencies will contain remarks about deficiencies.
- 7. Experience: The tenderer must have minimum 5 (five) years of continuous experience (as on the date of tender opening) for the similar work (herein mentioned in the scope of work) in its own name in any of CSIR laboratories/Institutes or in other similar R&D government organizations like ICMR/ICAR/DRDO/ISRO etc. (supporting document must be attached to this effect)
- 8. **Amount claimed in the bill:** Further it is specifically and clearly understood that the bills should be tendered only for sums entitled under this contract. All the taxes shall be as per government norm.
- 9. Payment of Bills: CSIR-NML, Jamshedpur shall make every effort to examine and arrange payment of bills through bank immediately after the receipt of bills maximum within 30 to 45 days of receipt. However, delay in settlement of payments shall not be accepted as valid ground for the firm to delay in clearance of consignments. It is clearly and specifically understood that storage/demurrage charges incurred on account of delay in clearance of consignments on grounds of delay in payment of bills on the part of CSIR-NML, Jamshedpur, will have to be borne by the CHA. All the bills will be admitted by CSIR-NML, Jamshedpur only for the sums entitled under this contract. CSIR-NML, Jamshedpur does not undertake to communicate to the firm, reasons for partial or non-admission of one or more claims made in the bills. TDS & other deduction if any shall be deducted as per government rules.
- 10. Fidelity Bond: As the firm shall handle sophisticated and valuable consignments, Hence it shall furnish a fidelity guarantee bond for an amount of Rs. 20.00 Lakhs in favour of Director, CSIR-NML, Jamshedpur to safeguard the interest of CSIR-NML in the event of any loss to CSIR-NML due to any act of omission and commission by the firm.
- 11. **Customs Duty:** The firm will bear the applicable customs duty up to Rs. 1,50,000/- on behalf of CSIR-NML, in each case which will be reimbursed to the bidder along with the bill. In case the amount of customs duty is more than Rs. 1,50,000/- the firm shall intimate CSIR-NML about the applicable duty in advance on the basis of purchase order so that the custom duty can be arranged well in advance. Any delay in intimating CSIR-NML about the duty payable shall be to the account of the bidder and consignment clearance should not be stopped for this. No plea on account of delay in arranging the custom duty shall be accepted. Any difference upto Rs. 20,000/- between the advance custom duty and actual amount of duty shall be paid by before at the time of clearance. In case of excess payment of duty to IAAI refund shall be recovered from IAAI by the CHA itself.

- 12. **Special arrangements for perishable consignment:** Some of the consignments are highly perishable in nature. The CHA will have to arrange dry ice stuffing (including procurement and filling-up) of the consignments at his storage place at the airport/ post office on its arrival and till their clearance and delivery at CSIR-NML. The firm has to get perishable/dangerous consignments cleared within 24 hours of arrival and delivered them at CSIR-NML at the earliest possible after clearance. In case, the perishable consignment is damaged on account of insufficient dry ice during storage, clearance or transportation the firm will be held responsible for the damage and the loss will be recovered from the payments due to them.
 - 13. Excess remittance of customs duty: The firm is required to actively follow-up cases of recovery of excess duty paid to customs.
 - 14. **Maximum amount of freight:** The firm shall bear a maximum amount of Rs. 1,00,000/- as freight for a single consignment that it can pay on behalf of CSIR-NML, Jamshedpur and get it reimbursed from CSIR-NML, Jamshedpur through bills after clearance and receipt consignment at CSIR-NML, Jamshedpur. No advance for freight amount will be given, neither for international freight nor for domestic transportation.
 - 15. Efficiency Rating: CSIR-NML Jamshedpur's yardstick for judging the efficiency of the firm shall be as follow.
 - Minimizing/altogether eliminating payment of storage charges for duration beyond free time and/or demurrage charges.
 - Co-coordinating with customs/carrier and obtaining cargo arrival notice (CAN) within a day and forwarding CAN to Stores & Purchase Department of CSIR-NML, Jamshedpur.
 - Custom Duty payment within stipulated period for interest/penalty free duty payment.
 - Expeditious clearance and delivery of consignments to CSIR-NML, Jamshedpur after receipt of all the documents from CSIR-NML, Jamshedpur.
 - 16. **Transit insurance:** The CHA shall be responsible for arranging insurance for the shipments finalized on ex-works and FOB basis. Kindly confirm your willingness to arrange the same.
 - 17. General Services: CSIR-NML, Jamshedpur expects that the firms should have good reputation in market, must have good rapport with customs authorities to avoid/minimize delay in customs clearance and not refer petty matters to CSIR-NML.
 - 18. **Other charges/levies**: All statutory charges/levies not mentioned in the format rates etc., will only be paid on the production of original receipt/ voucher for the same.
 - 19. **FOB Shipments**: Many orders are placed with foreign supplies on FOB basis. The console airfreight rates must be based on FOB shipments i.e. from shipping airports in the exporting country to Kolkata airport. Inland handling/forwarding charges in the exporting country will not be separately payable by CSIR-NML, Jamshedpur.
 - 20. **EX-Works shipments:** In case the foreign supplier agrees to supply the goods on Ex-works basis only, the CHA shall arrange collection and shipment of the consignment from the foreign supplier to CSIR-NML. Inland handling/forwarding charges in the exporting country will be reimbursed by CSIR-NML, Jamshedpur with prior approval of CSIR-NML on the charge.
 - 21. **Follow-up of shipments:** Copy of the order placed by CSIR-NML, Jamshedpur on foreign supplier will be forwarded to the CHA. It is then its sole responsibility to follow up the matter with its foreign associates and foreign supplier to ship the goods within delivery schedule.
 - 22. Inspection Facility: The firm shall, if required by CSIR-NML, Jamshedpur, carry out or arrange to carry out inspection (arrangement of third party inspection reports) of the ordered material at the country/port of

shipment/suppliers premises and also inspection of the packing/labelling/markings etc. (as per international packing standards & norms).

- 23. **Custody of consignments:** Safe custody of consignment cleared is the responsibility of the CHA till they are delivered to CSIR-NML Jamshedpur. The CHA may also be required to arrange and obtain insurance policy for FOB/FCA consignments on behalf of CSIR-NML, Jamshedpur and assist in processing and liaison of claim(s) if any, lodged by CSIR-NML, Jamshedpur in the event of any damage, etc.
- 24. **Short landing:** Whenever any short landing cargo is noticed, the firm shall file "Not found" or "Not traceable" notice with the Airport Authorities, obtain 'Not traceable certificate', and also lodge formal claim with the airport authorities/airlines concerned with all necessary documents under intimation to CSIR-NML, Jamshedpur.
- 25. **Inspection of packages and insurance survey:** It is incumbent on the firm to carefully examine all the packages marked for customs examination of each consignment with the respective invoices and measurement/packing list etc., If at the time of physical examination of the consignment, any damage or loss of goods in noticed, the same shall be immediately brought to the notice of the CSIR-NML, Jamshedpur for arranging an insurance surveyor for surveying the consignment. The firm shall pay fee of the Surveyor and bear expenses for carrying on the survey and the expenditure to be reimbursed on submission of valid receipts.

26. Liaison and co-ordination with CSIR-NML, Jamshedpur: The firm shall-

- Maintain close liaison regularly with CSIR-NML, Jamshedpur.
- Take immediate steps for finalization of the BE from time to time and shall see that they are filed with the customs authorities in time.
- Arrange for one of its employees to be in daily contact with concerned staff of Purchase Department of CSIR-NML, Jamshedpur. The representative shall make all necessary arrangements in advance for proper handling and delivery of consignment at the destination/site for installation.
- 27. **Delay in filling documents:** The CHA shall be responsible for any delay in filling BE with customs authority and/or not notifying CSIR-NML, Jamshedpur of discrepancy, if any, in the documents. The storage/demurrage charges (other than handling charges) for the entire period of delay due to deficiency or negligence in service on the part of the CHA will have to borne by them. Further, the CHA will have to make good loss/damage, if any, suffered by CSIR-NML, Jamshedpur on account of delay due to deficiency or negligence of service attributable to it in filing BE and/or clearance of consignments. The firm shall have to clear the consignment within the free time allowed by the Kolkata International Airport Pvt. Ltd. or any other airport/port CSIR-NML, Jamshedpur shall not bear/pay any demurrage charges on account of any delay on the part of the firm.
- 28. Safe custody of Custom Duty Exemption Certificate (CDEC): The firm shall be responsible for safe custody and proper use of CDEC provide by CSIR-NML, Jamshedpur.
- 29. **Delivery of consignment:** The firm shall arrange delivery of the consignments at the earliest possible point of time but not more than 5 working day in any case from the date of clearance of consignment. Delivery may be affected during working hours, as far as possible. In respect of perishable, CSIR-NML, Jamshedpur will accept delivery beyond office hours and on all holidays.
- 30. Non-interruption of service: Should any dispute of any nature arise, the firm shall continue its services as provided in this contract, if required by CSIR-NML, Jamshedpur, during pendency of resolution of the dispute.
- 31. **Customs query**: The CHA shall equip itself in advance with all necessary information that may be required for answering customs queries. It shall take any necessary steps to answer both oral/verbal and written queries without any delay. In case of need of clarification from CSIR-NML, Jamshedpur, the queries may be communicated

to CSIR-NML, Jamshedpur on the day the queries are raised. Storage/demurrage charges incurred on account of delay in communicating the queries to CSIR-NML, Jamshedpur shall be borne by the CHA and further, damage caused to CSIR-NML, Jamshedpur due to the above said delay shall be made good by the CHA.

32. **Continuation of services during pendency of payment of bills & disputes:** CSIR-NML, Jamshedpur will make every effort to arrange payment of bills within 30 to 45 days of receipt. If payment is delayed beyond 45 days for any reason the firm shall NOT STOP clearing consignments and their delivery at CSIR-NML, Jamshedpur. The firm should have adequate financial standing to continue clearance activities during pendency of payment of bills. If there is any dispute of any type between CSIR-NML and the successful CHA, the successful CHA will have to continue its services as provided in the contract during pendency of resolution of such dispute/issue. CHA will not hold any of our consignment pending with them due to such dispute/issue. (Please attach undertaking to this effect)

33. **Settlement of Disputes:** The Purchaser and the supplier shall make every effort to resolve amicably by direct informal negotiation any disagreement or dispute arising between them under or in connection with the Contract. If, after Twenty-One (21) days, the parties have failed to resolve their dispute or difference by such mutual consultation, then either the Purchaser or the Supplier may give notice to the other party of its intention to commence arbitration, as hereinafter provided, as to the matter in dispute, and no arbitration in respect of this matter may be commence arbitration has been given. Any dispute or difference in respect of which a notice of intention to commence arbitration may be commenced prior to or after delivery of the Goods under the Contract.

The dispute settlement mechanism/arbitration proceedings shall be concluded as under:

(a) In case of Dispute or difference arising between the Purchaser and a domestic supplier relating to any matter arising out of or connected with this agreement, such disputes or difference shall be settled in accordance with the Indian Arbitration & Conciliation Act, 1996, the rules there under and any statutory modifications or re-enactments thereof shall apply to the arbitration proceedings. The dispute shall be referred to the Delhi International Arbitration Centre (DIAC), Delhi High Court, New

Delhi. The award of the arbitrator so appointed shall be final, conclusive and binding on all parties to this order.

The venue of the arbitration shall be the place from where the purchase order or contract is issued. Notwithstanding any reference to arbitration herein,

- (a) The parties shall continue to perform their respective obligations under the Contract unless they otherwise agree; and
- (b) The Purchaser shall pay the Supplier any monies due to the Supplier.

All disputes in case of any award under the proposed Rate Contract shall be subject to Jamshedpur, Jharkhand jurisdiction.

34. <u>Yardstick for annual performance for extension of contract on yearly basis:</u>

As the period of contract shall be valid for a period of one-year subject to renewal on annual performance basis, the following

points will be used to evaluate the performance of the successful bidder:

a) In the preceding year(s) of the contract there is not any case of payment of demurrage or other such storage charges by CSIR-NML (wherein CHA has not agreed for bearing of demurrage charges etc.). CHA will have to clear the consignment within the free period allowed by the concerned custom/airline authorities.

- b) Proper coordinating with the custom authorities or airline/carrier and obtaining cargo arrival notice (CAN) within a day and forwarding the CAN to Purchase Department of CSIR-NML.
- c) Expeditious clearance and delivery of the consignments to CSIR-NML after receipt of all the concerned clearance document from us.

- c) The CHA, under no circumstances will charge the airfreight rates more than airfreight rates specified in the latest issue of IATA Tact book. (Please attach undertaking to this effect)
- d) India's national airline i.e. Air India may be preferred for the consolidation services by the CHA. In case the AIR India flight is not available then CHA will have to ship the consignment through the first available console of any airline.
