- 1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. - 4. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

- 2. **Qualification Requirement:** Please refer to the technical specifications of the bi

- 3. **Delivery Period:** Delivery should be completed in full within a period of ninety (9 0) days from the date of purchase order. Liquidated Damage clause will be impose d in the event of non-completion of delivery within the stipulated time.
- 4. **Liquidated Damage clause**: The penalty shall be 0.5% per week or part of a we ek towards late delivery and installation, commissioning, training etc. including all contractual obligations beyond contractual deadline. The maximum amount of penalty shall be 10%.
- 5. **Delivery Site**: Delivery F.O.R. CSIR-NML, Jamshedpur-831007 (Jharkhand).
- 6. There can be only one bid from the following:
- a. The original manufacturer directly or through one authorized dealer on his behalf; and
- b. Authorized dealer on behalf of only one manufacturer.
- 7. **Installation commissioning and Training:** To be installed and commissioned a t site by the supplier within fifteen (15) days from the delivery period. Training is r equired for one day for five (05) nos. of persons. The inspection of the material shall be done within 30 days after installation of the goods.
- 8. **Warranty:** 02 (two) years from the date of successful installation and commission ing.
- 9. **AMC:** Vendor must quote consecutive 1 year AMC rate (minimum 02 preventive + 1 breakdown per year) for equipment after warranty. The prices will be included in evaluation.
- 10. **OEM Certificate** (applicable for manufacturer only): In case the Bidder is the OEM, a declaration to this effect must be attached along with the offer. This ce rtificate with valid date must contain Name, Designation, Email Address and Mobil e Phone Number of the authorized signatory along with the address of the office.
- 11. **MAF Certificate** (applicable for dealer only): In case the Bidder is offerin g products on behalf of the OEM, a proper Manufacturer's Authorization Certificate (MAF) with valid date must be attached with the quotation and it should contain N ame, Designation, Email Address and Mobile Phone Number of the authorized sign atory along with the address of the office.
- 12. **Taxes, Duties etc.**: The buyer should indicate full GST rates.
- 13. **Make In India:** Preference will be given to offer/s for Class-I MII product. The Bi dder must furnish a declaration/Certificate to this effect along with the bid mentio ning about the percentage of Local Input of the offered product and the detailed address of the place (manufacturing unit) where the input is being added. The D eclaration/Certificate should have full name and designation of the signatory alon g with his/her email ID, direct phone number, office address.

As per Govt. of India procurement policies the eligibility of the suppliers for this bi dding is restricted to Class I and Class II local suppliers as per Department for Promotion of Industry and Internal Trade, Govt. of India, vide OM No. P-45021/2/2017 -PP (BE-II) dated 04 June 2020 and OM No. P-45021/2/2017-PP (BE-II) dated 16 Se ptember 2020.

- 14. **MSE:** Preference will be given to MSEs. The bidder must submit valid documents for claiming them as eligible MSEs for the particular bid/item.

- 16. **Certificate reg. Land Border Sharing is compulsory**. Any bidder from a cou

ntry which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority. While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws.

- 17. **EMD:** The bidder has to submit an EMD along with the bid for amount mentione d in EMD details. EMD should be provided on the name of Director, CSIR-NML, Jam shedpur.
- 18. **Payment Terms**: Hundred percent (100%) of the Contract Price of Goods received shall be paid within thirty (30) days of receipt of Goods and successful installation & commissioning upon submission of claim supported by the acceptance certificate issued by the Purchaser along with the Performance security.

- 19. **Performance Security:** The vendor has to submit a Performance Security equi valent to 3 (three) per cent of the purchase order value before release of paymen t. The performance security should remain valid for a period of warranty plus six ty (60) days from the date of successful installation and commission of the suppli ed equipment.
- 20. **Bid Securing declaration**: Submission of Bid Securing Declaration is compulso ry.
- 21. The place of jurisdiction is Jamshedpur, Jharkhand, India.
- 22. **Catalogue/Leaflet/Brochure:** Bidder must submit Catalogue / Leaflet / Brochur e to justify the specification/feature of their offered equipment.
- 23. The bidder should ONLY attach the requisite documents, asked for. The Bidder's hould not attach "IRRELEVANT DOCUMENTS" or "DOCUMENTS WHICH HAVE NOT BEEN ASKED FOR".
- 24. In the event of non-compliance of any of the aforesaid guidelines, the offer of the bidder may be treated as non-responsive.

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for attached categories, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

Additional Clause For Annual Maintenance Charges

- **1.**AMC charges to be indicated as percentage of cost of Product/Equipment quoted for each year after the warranty period.
- **2.** GST shall be included in the AMC Charges quoted.
- **3.** The AMC functionality shall be available in bid only and no direct RA shall be applicable. In case of bid to RA decrement rules shall be applicable on total price inclusive of AMC charges.
- **3.1** Buyer shall indicate number of years of warranty by selecting option of 1- 10 Years available in the field depending on warranty parameter applicable in category parameters for the equipment. The Seller while participating in Bid/RA will get fields to indicate AMC charges as percentage depending on number of years of AMC selected by Buyer. The following shall be applicable If 5 year AMC selected.
- **3.1.1** AMC charges for first year after warranty period Percentage to be indicated- A1.
- **3.1.2** AMC charges for second year after warranty period Percentage to be indicated A2.
- **3.1.3** AMC charges for third year after warranty period Percentage to be indicated A3.
- **3.1.4** AMC charges for fourth year after warranty period Percentage to be indicated A4.
- **3.1.5** AMC charges for 5th year after warranty period Percentage to be indicated A5.
- **3.2** The calculation of AMC Charges shall take in to account of number of years of warranty and duration of AMC as specified while creating bid.

- **3.3** AMC charges to be indicated for each subsequent year should be same or higher than preceding year.
- **3.4** The AMC charges shall be offered within range of 3 to 10% of cost of equipment.
- **4.**Since AMC charges are to be paid only later for each year during AMC period , applicable performance guarantee amount after placement of contract shall be based on the cost of product/equipment and not on basis of cost of equipment along with AMC Charges.
- **5.** Performance bank guarantee applicable for AMC is to be submitted at start of the AMC and shall be applicable as 3% on the total contract value including AMC Charges The PBG submitted after award of contract shall be released only after new PBG for the AMC period is submitted and accepted by buyer/consignee after due verification. Bank guarantee for AMC is to remain valid till completion of AMC period plus one year .The bank guarantee for AMC shall be submitted to buyer directly.
- **6.** In case of splitting of quantity product/equipment cost and AMC charges offered by L-1 in the evaluated cost shall be matched by higher quoting eligible bidders on one to one basis .The equipment cost shall be matched and AMC charges shall be matched year to year.
- **7.** The AMC Contract shall be an offline contract to be handled by buyer. The payment of AMC will be made on AMC frequency (as indicated above) basis after satisfactory completion of said period, duly certified by end user and scope of AMC will be as per para 1 above.
